The FBU legal service for ROOT members is provided by Thompsons Solicitors, the UK's only dedicated trade union solicitors. In 2015 Thompsons Solicitors secured £3,291,812 in damages for FBU members. ROOT members and their families will like, all other members, pay either nothing for the service or pay a discounted rate.

LEGAL SERVICES FOR EVERY STAGE OF LIFE

The FBU offers workplace injury, employment law and criminal law protection, making sure members are protected whilst working. ROOT members benefit from a tailored version of this service whether moving house or down-sizing, seeking advice on neighbourhood disputes or wanting to get their financial affairs in order by writing a will, the FBU is proud to offer a variety of legal services in the areas of law that matter most to ROOT members.

You may be paying for legal protection and cover through a legal expenses insurance ("LEI") policy added onto your car or home insurance. Paid-for LEI policies often cover the cost of advice about how to handle a dispute with a contractor or tradesman, or on how to settle contractual issues when selling a house. They sometimes also cover costs associated with making a claim against a person or organisation if you're injured.

But the legal service package you get as part of your ROOT membership provides similar protections, totally free of charge.

Your membership brings a wide package of protections from experts and is better value for you and your family.

**Claims must be brought within three years of the date of an accident or diagnosis. Exceptions do apply, please speak to Thompsons for advice on whether or not you have a claim.*

****Reduced rates within the union scheme. There are no legal fees but a 10% cost will be deducted from any final settlements. This is a discounted rate for FBU members, non-union members pay a 20% deduction from their damages.*

LIFELONG LEARNING COURSES AND QUALIFICATIONS

The FBU Lifelong Learning Project organises a variety of accredited courses and qualifications each academic year, including distance learning. ROOT members and family members aged 19 or over are eligible to take these courses. The FBU learning centres work in partnership with further education providers to deliver a range of courses and recognised qualifications in IT, Maths, English, Preparation for Life and Work, Health and Social Care, and Business and Administration.

These courses range from short taster courses to extended programmes of learning, which you can work through at your own pace to achieve qualifications that are accredited by City and Guilds, NCFE, and the BCS. All courses allow you the option to learn at your local FBU learning centre, at home, at work and at a time that best suits you.
